Our Governors work together to provide independent oversight of the management and operation of our school, with the aim of improving the quality of education provided and raising standards. The governing body has three core functions;

- Holding the headteacher to account for improving the school
- Ensuring financial health, probity and value for money

Our governing body has 11 members which are made up as follows:

- 3 co-opted governors

As well as the full governing body, we have two committees which meet regularly each term

- To review any appropriate policies not considered by other committees

## Finance & resources committee

- To monitor and approve the school budget;
- To determine the pay policy;
- To monitor a termly health and safety check; to monitor any building works;
- To review the asset management plan;
- To review and approve the school staffing structure;
- To consider any premises related matters and make recommendations to the full governing board;
- To consider any sustainability issues and make recommendations to the full governing board.
- To have the delegated powers to approve the School Fund Account.
